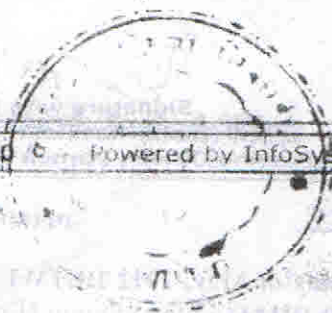

WHEREAS the settler is basically a Social activist involved deeply in advancement, upliftment and all round development of the society by educating the people at large of different age group. He is desirous of founding a school in and around Purnea for the education of boys and girls in the educative and vocational pursuits.

AND WHEREAS the settler is desirous to endowing Rs. 1,00,000/- as per schedule "A" for the purposes of founding a Public Trust for the objects & purposes detailed hereinafter.

AND WHEREAS the Trustee have also agreed to carry out the Trust here in created.

NOW THIS INDENTURE WITNESSES AS FOLLOWS-

1. Name & Address of the TRUST :- Name of the Trust shall be "DEVYANI EDUCATIONAL TRUST" & presently office of the Trust shall be situated at "C/o Vinay Kumar Singh, Newa Lal Chowk, Power Grid Road, P.S.- K. Hat, Dist. - PURNEA."

Office of the Trust may change after decision of the Board of Trustees if needed in the interest of the Trust.

2. Object of the Trust shall be-

Main Objects-

- (i) To run and or manage school / collage / technical education centers / vocational education centers / training center / for educating the boys and girls and to develop character of the students as well as educate them in physical culture.
- (ii) To run and or maintain boarding house for the students.
- (iii) To manage the working of "New Modern Public School" at Bihariganj running since before

For meeting the above main objects the Trust will do all acts in regards-

(a) To open, found, establish, promote, maintain, run, and / or manage school, College, for the students both boys & Girls for providing general education right up from Nursery up to Graduation level for the students both boys & Girls for providing general education right up from Nursery up to Graduation level.

(b) To open, found, establish, promote, maintain, run and / or manage technical education centers for the students both boys & Girls for their Technical Education.

(c) To open, found, establish, promote, maintain, run and / or manage Engineering / Medical / Para Medical Colleges for running Degree and Diploma courses for the students both boys and girls.

(d) To obtain Permission, License, Certificate and / or Authority for running and / or managing education Centers like school / College / technical education center / Engineering / Medical / Para Medical Colleges.

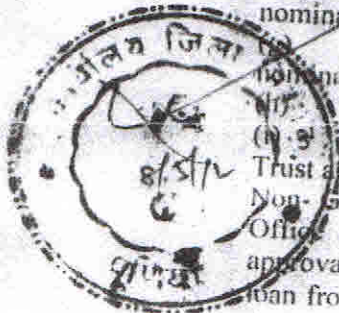
property or properties or advancing money or mortgage, they shall be entitled to accept such title or evidence of titles as they shall think fit in their absolute and uncontrolled discretion.

3 Declaration of the TRUST:-

WHEREAS the Settler has delivered the cash amount to a sum of Rs. 1,00,000/- as mentioned in Schedule "A" to the Trustee to hold the same and to use for the Trust with and under the power & provisions herein contained.

4 Trustees and their powers:-

- (a) That both the Trustees shall be the permanent Trustees having rights of succession i.e. In case of death of any permanent Trustee his heir will succeed him as per his family arrangement, failing which elder son / daughter will join as Permanent Trustee
- (b) That as per requirement Permanent Trustees will appoint General Trustees for the purposes of smooth functioning of the Trust.
Number of the General Trustees shall be maximum 5 and their nomination will be made for the period of maximum THREE years having re-nomination option.
- (c) That nomination of the Trustees will be made by the Life Time Trustees considering the reputation, contribution and achievements of the person towards the society in connection with the objects of the Trust.
- (d) That the Trustees may retire at any time without assigning any reason & without being responsible for any cost occasioned by such retirement.
- (e) That there shall be a Board of Trustees comprising of Permanent Trustees. For the time being Smt. Anu Devi will be the **CHAIRPERSON** & Sri. NARESH BHAGAT will be the **SECRETARY** of the Trust for FIVE years and thereafter Board of Trustee will elect the Chairman & Secretary for further Five Years and so. The Board of Trustees will elect other office bearers from among them for proper management of the Trust property. Elected office bearers shall hold their responsibilities for **TWO** years from the date so elected.
- (f) That rights and responsibilities of the nominated Trustees shall seize just after expiry of **THREE** years from the date of their nomination as Trustees. Nominated Trustees shall be given One month prior information about expiry of the period of their nomination as Trustee.
That after seizure of the rights of nominated Trustee, any / or of them may be re-nominated as Trustee for the further term.
- (g) That Permanent Trustees shall be in-charge of the day to day affairs of the Trust. That in case any financial assistance is required for proper management of the Trust and to meet the objects of the Trust, Finance may be taken from any Government / Non-government / Semi Government / Financial Institution / Nationalized Bank / Post Office / other Financial Institution / Society / Organization / any Individual after approval of the Board of Trustees. Trust property may be mortgaged for obtaining any loan from any organization / Bank / Financial Institution / Individual, after approval of the Board of Trustees. The Permanent Trustees shall be responsible for repayment of all type of Loan taken in the interest of the Trust.
- (j) That the Permanent Trustees shall be entitled to get adequate remuneration for their whole time engagement in course of management of the Trust and the amount of such remuneration shall be decided by the Board of Trustees. Any Trustee may for-go / disclaims such remuneration voluntarily.

- E To assist, finance and / or help in setting up / maintaining / managing / running any **educational institution including technical and / or vocational and to obtain affiliation thereof from recognized Board and / or University and / or appropriate authority.**
- F To open, found, establish, promote, maintain, assist, finance and / or help in setting up / maintaining / managing / running any **Hostel, Laboratory, Library, Reading Rooms, Auditorium and / or play grounds for the students.**
- G To open, found, establish, promote, maintain, assist, finance and / or help in setting up / maintaining / managing / running any **Hospital, Charitable dispensaries, Maternity Homes, Diagnostic Centers, Health Check up Centers etc for welfare of the Society.**
- H To establish, develop, maintain and / or grant aid in cash and / or in kind to hospital, Medical College, B.Ed. College, Nursing institution, Child welfare center.
- I To establish, maintain, and run **studentship, scholarship** and render other kind of aid to students including supply of books, other educational and or vocational materials, stipend, medals and other incentives to the students without any distinction as to caste, colour, race, creed or sex.
- J To promote, establish, support, maintain or grant aid for the promotion of Science, Culture, Literature, Music, Drama and / or Fine Arts for preservation of monuments and for research.
- K To provide all round education and / or support to physically challenged and the needy persons.
- L To **Publish any Book, Journal, News Paper, Magazine and / or periodical** for spread and / or advancement of activities and advertisement.
- M To provide **all round assistance to the needy persons including Children, women and Old men.**
- N To protect the environment.
- O To promote, assist and / or maintain, such other social or cultural activities as may be necessary for achieving the object of the Trust and conducive to the well being and general welfare of the people.

WHEREAS it is further declared that the Trustees shall be entitled to add the objects of the Trust with consent of the settler, subject to the condition that any such addition shall be confined solely to the purposes to the welfare of the public at large.

The Trustees will have discretion to decide on financing, patronizing or assisting any one or some or all such objectives and purposes as they alone, in their absolute and uncontrolled discretion, would deem fit and proper or on the priorities as they, in their uncontrolled discretion might appreciate, assess and observe.

WHEREAS subject to the provisions of Income Tax Act 1961 as amended from time to time, the Trustees will keep the Trust fund or such portion thereof, as they may, in their absolute discretions, think fit and proper, without being answerable or accountable to the beneficiaries or any other party for any loss invested in such share, stocks, securities and debentures of any joint stock company or in the purchase or acquisition or construction of any immovable property including building and / or in the purchases and acquisitions or mortgage by way of fresh charges on any immovable property in India of free hold or lease hold tenure and may deposit the amounts with any scheduled Bank, Company or Private Firm or individual on such terms and conditions as they think fit. In the matter of investment of Trust fund, the provisions of Section 20 of the Indian Trust Act shall apply. In the event, if the Trustees purchasing any immovable

- (k) That the Trustees shall be entitled to get conveyance and other expenses for their movement in course of management of the Trust.
- (l) That the Board of Trustees shall be entitled of making rules / by laws for management of the Trust and meeting its objects.
- (m) That a **Bank account** will be opened in the name of the Trust in any Nationalized bank after approval of the Board of Trustees and the account shall be **operated jointly** by the Chairman & Secretary.
- (n) That out of income of the Trust fund the Trustees shall defray the expenses for meeting the objects of the Trust.
- (o) That the Trust may receive donation from all individual (living in India and abroad) / Society / Organization etc. for meeting the objects of the Trust.
- (p) That surplus Trust fund may be invested for gaining profit after approval of the Board of Trustees.
- (q) That the settler shall have the rights to add / alter / amend / change / any of the guidelines settled for the Trustees in the interest of the Trust.
- (r) That the Trustees will appoint a legal advisor for supervision of all activities of the Trust and to do all acts in the interest of the Trust. He will be responsible for monitoring all the decisions considering the benefits and interest of the Trust.
- 5 **WHERE AS** if any Trustee become bankrupt or found guilty by court for an offence involving moral turpitude or become insolvent or remains absent from the meeting of the Trust for **THREE** consecutive months or resigns from his post or other wise in incapacitated physically the permanent Trustees may nominate other Trustee for a term.
- 6 **WHERE AS** if any Trustee is found indulged in any such activities which are against the interest of the Trust, permanent Trustee will be at liberty to strike out his name from the Board of Trustees just after giving him a notice for the effect.
- 7 **Where As** for meeting the objects of the Trust, the Trustees will arrange suitable accommodation for running the School, College, Technical education centers, Hospital, Laboratory, Library, Play Ground etc either on rent or by out right purchase out of the Trust fund or by way of donation from any individual or organization.
- 8 **Where As** a separate guide line will be settled for proper running and management of all education center, School, College etc. and management of the concerned institution will be done by an exclusive managing committee under strict control of the permanent Trustees.
- 9 **WHEREAS** in case of difference of opinion between the Trustees, decision of the majority will prevail and decision of the Permanent Trustees will be binding on all.
- 10 **WHEREAS** the Board of Trustees will appoint / engage suitable / competent / trained persons for performance of the accounts / Construction / and / or any work for the time being on proper remuneration.
- 11 **WHERE AS** No part of the Trust fund either the corpus or the income there from shall be utilized for the object other than that of Trust.
- 12 **WHERE AS** in case of failure of the Trust or having become impossible of performance of the Trust, Property and the Fund of the Trust shall be transferred to other Trust of similar objects with approval of the Settler.
- 13 **WHEREAS** this is a Public Registered Trust the property of the Trust shall in no way revert to the Settler or any person.
- 14 **WHERE AS** value of the Trust property is hereby assessed to a sum of Rs. 1,00,000/- and proper stamp duty is being paid on the same as per the provisions of the Indian Stamp Act

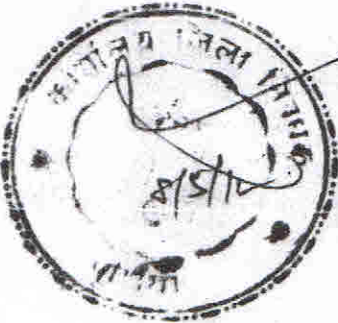
